## Manned Pest Control Aircraft Pilot Certificate Requirements

**Do you need this certificate?**

You must possess a Department of Pesticide Regulation (DPR) Pest Control Aircraft Pilot Certificate if you operate an aircraft to conduct pest control in California, pursuant to Food and Agricultural Code section 11901 (FAC 11901). Example: pilots employed by a licensed Pest Control Business, pilots employed by vector control agencies or districts, and pilots who do pest control on their own property (private applicators<sup>1</sup>).

**Dealer designated agent privilege**

Under this certificate you may also act as a licensed Pest Control Dealer Designated Agent, which allows you to actively supervise operations at one Pest Control Dealer location.

**Basic certification requirements**

<sup>1</sup> An individual who uses or supervises the use of pesticides to produce an agricultural commodity on property owned, leased, or rented by him/her or his/her employer; OR a householder who uses or supervises the use of a pesticide outside a residential dwelling to control ornamental, plant or turf pests on residential property owned, leased, or rented by that householder.

## Unmanned Pest Control Aircraft Pilot Certificate Requirements

**Do you need this certificate?** You must possess a DPR Pest Control Aircraft Pilot Certificate if you operate an unmanned aerial system (UAS) to conduct pest control in California (FAC 11901). Example: pilots employed by a licensed Pest Control Business, pilots employed by vector control agencies or districts, and pilots who do pest control on their own property (private applicators<sup>2</sup>).

**Dealer designated agent privilege** Under this certificate you may also act as a licensed Pest Control Dealer Designated Agent, which allows you to actively supervise operations at one Pest Control Dealer location.

**Basic certification requirements** The following table illustrates the basic requirements for this certificate:

<sup>2</sup>UAS may be operated in pest control by a pilot holding either a Manned or Unmanned Pest Control Aircraft Pilot Certificate. If you already hold a Manned Aircraft Pilot Certificate with DPR you do not need to obtain an Unmanned Aircraft Pilot Certificate to operate UAS for pest control.

**Examinations**

**Apprentice Pilot Certificate:**

You must pass the Laws, Regulations, and Basic Principles and Apprentice Pilot Certificate examinations with scores of 70 percent or higher to obtain the Apprentice Pilot Certificate.

**Journeyman Pilot Certificate:**

You must pass the Journeyman Pilot Certificate examination with a score of 70 percent or higher to obtain the Journeyman Pilot Certificate.

**Vector Control Pilot Certificate:**

You must pass the Vector Control Pilot Certificate examinations with scores of 70 percent or higher to obtain the Vector Control Pilot Certificate. Vector Control Pilot applicants are not required to take the DPR examination for Laws, Regulations, and Basic Principles.

**Exam schedule/  
processing time**

The DPR Exam Schedule is posted on DPR’s web site at [www.cdpr.ca.gov/docs/license/liccert.htm](http://www.cdpr.ca.gov/docs/license/liccert.htm). Your application must be mailed by the final postmark date listed in the examination schedule in order for your requested month, location, and type of examination(s) to be processed.

**Preparing for  
examinations**

To prepare for the examination, you should read the appropriate study materials listed on the Suggested Study Material Source List included in this packet. Many of the study guides have practice test questions at the end of each chapter that can help you evaluate whether you know the material well enough to pass the exam. The Knowledge Expectations are included on the Suggested Study Material Source List, which outline the type of information from the study materials you will be expected to know when you take the examination.

**Application fee**

The application fee for the Pilot Certificate is \$60 (Title 3 of California Code of Regulations [3 CCR], section 6502). This fee allows an applicant a 12 month period to become certified.

**Examination  
fees**

The examination fee is \$50 (3 CCR section 6505) for each examination requested, including rescheduling due to failure to appear or obtain a passing score.

**Second-year  
fee notice**

If you pass the required examinations you may receive a Second-year Fee Notice. If you receive this notice, it means that in order to issue your 2-year certificate an additional \$45 is required. The 2- year cycles are illustrated in the table below.

**Once you become certified**

If you are an Apprentice Pilot, you can only conduct pest control activities under the direct supervision of a Journeyman Pilot. Note that only a Manned Journeyman Pilot can supervise a Manned Apprentice Pilot (3 CCR section 6540[b]).

---

**County registration**

Before you conduct any work, you must register with the County Agricultural Commissioner's office in each county that you intend to perform pest control. Most counties require a fee for registration, which covers one calendar year. For a list of county registration fees, please go to our web site at:

**Continuing education**

Once you pass the examination(s) and receive your certificate, you must complete the required a continuing education (CE) hours. You are required to complete at least 20 hours of approved CE every two years before your certificate expires. At least four of the 20 hours must cover the category of pesticide laws and regulations and at least four hours must cover aerial pest control equipment and application techniques (3 CCR section 6511). Note that some new certificate holders may require fewer CE hours for their first renewal depending on when the certificate was issued (see the CE requirements link below).

**Renewal fee**

The renewal fee is \$90 for the 2-year cycle (3 CCR section 6502).

**Late renewal fee**

A late fee of 50 percent of the total renewal fee will be charged for each license or certificate postmarked after December 31 of your expiration year.

- not specifying your preferred month, location, and type of examination(s).

You can avoid these errors by reading the application instructions carefully and by mailing your application **before** the final filing date.

# Pest Control Aircraft Pilot Certificate Application Instructions

## Failure to complete or provide the requested information may delay the processing of your application.

DPR will only disclose personally identifiable information, such as home phone number and personal email address, to third parties as required by state or federal law or regulation and consistent with the Information Practices Act (Civ. Code, sections 1798-1798.78).

### A. Application Type: Check the appropriate box.

**New Application:** If you:

- \*Are applying for a Pest Control Aircraft Pilot Certificate (Pilot Certificate) for the first time.
- Failed to obtain your certificate within 12 months from the first date you scheduled your examination.
- Failed to meet the renewal requirements.

**New Manned Pilot Certificate** applicants **must** submit: (1) A copy of their valid Federal Aviation Administration (FAA) Commercial Pilot's Certificate; and (2) A current Medical Certificate issued by the FAA.

**New Unmanned Pilot Certificate** applicants **must** submit: (1) Proof of FAA approval for the individual to pilot an Unmanned Aircraft System (UAS) for pest control; and (2) Proof of FAA approval to use UAS for pest control.

Note: UAS may be operated in pest control by a pilot holding either a Manned or Unmanned Pest Control Aircraft Pilot Certificate, as long as you have the appropriate approval(s) from FAA.

**Reexamination:** Scheduling an examination on which you failed to obtain a passing score or failed to appear for a previously scheduled examination.

\*Applications for a new certificate shall include an attached copy of valid government-issued documentation verifying that the applicant will meet the required minimum age of 18 years old prior to admission to the examination. The applicant's name included on the submitted application shall match the name stated on the valid government-issued documentation submitted.

### B. Applicant Information: Enter your name (name shall match the submitted valid government-issued documentation); Pilot Certificate or Application Number (if applicable); date of birth; mailing address; E-Mail address; work and cell or home phone numbers; and current employer (if applicable).

**New Manned or Unmanned Apprentice Pilot** certificate applicants must successfully pass the Laws, Regulations, and Basic Principles examination and the Apprentice Pilot Certificate examination before the Apprentice Pilot Certificate is issued.

**New Manned or Unmanned Journeyman Pilot** certificate applicants must submit page three of the application demonstrating that they have been certified as an Apprentice and have worked under a Journeyman for a minimum of one year, and completed a minimum of 150 hours of operation of a fixed-wing aircraft or 50 hours of a non-fixed wing aircraft within the past two years. They must also successfully pass the Journeyman Pilot Certificate examination before the corresponding certificate is issued.

**New Unmanned Vector Control Technician** applicants must submit copies of their Department of Public Health Vector Control Technician certification in Category B - Mosquito Control with their application and successfully pass a Pilot Certificate examination before the Vector Control Technician Pilot Certificate is issued.

### C. Examination - Laws, Regulations, and Basic Principles: This examination is required of all new Apprentice Pilot Certificate applicants.

Exemptions: No fee or examination is required if you: (1) have a current Agricultural Pest Control Adviser License (PCA) or Qualified Applicator License (QAL) (to qualify for this exemption you must enter your current license number), or (2) have passed this examination within the past 12 months. The Qualified Applicator Certificate and Pest Control Dealer's Designated Agent License do not meet the exemption requirements. Structural Pest Control Operators and out-of-state licenses or certificates also do not meet the exemption requirements. The Laws, Regulations, and Basic Principles examination is not required for Journeyman and Vector Control applicants.
