SUBJECT: VIRTUAL PESTICIDE REGISTRATION WORKSHOP 2023

The Department of Pesticide Regulation's (DPR) Pesticide Registration Branch (PRB) is announcing the biennial Pesticide Registration Workshop. The event will be held virtually over two half-days on June 13 and 14, 2023 from 8 AM to 12 PM PDT.

The workshop will be interactive and include case scenarios that participants can work through with DPR staff. Topics will include pesticide products requiring registration, applying for pesticide product registration, data requirements, and changes after product registration. Attached is the tentative agenda.

ZOOM AND WEBCAST DETAILS

This is a virtual event through the remote meeting service Zoom. Space on Zoom is limited to 36 participants and priority will be given to company staff new to the California registration process. The interactive component of the workshop, the breakout sessions, will only be available and viewable for Zoom participants. The workshop will be webcasted, recorded, and posted to DPR's Web site, as a resource for interested stakeholders. Any recording made available will not contain the breakout sessions portion of the event.
