SUBJECT: VIRTUAL PESTICIDE REGISTRATION WORKSHOP 2021

The Department of Pesticide Regulation (DPR) is offering a virtual Pesticide Registration Workshop on August 25, 2021 from 8:00 a.m. to 5:00 p.m.

The workshop will be interactive and include case scenarios that participants can work through with DPR staff. Topics will include pesticide products requiring registration, applying for pesticide product registration, data requirements, and changes after product registration.
