

Pilot Language Access Hub

What is this?



The California Department of Pesticide Regulation (DPR) received funding from the US Environmental Protection Agency (EPA) to develop a pilot "Language Access Hub" for County Agricultural Commissioners (CACs).

Starting February 2024, CACs and their staff have access to a **document translation service** and a **24/7 interpretation call line** for their pesticide use enforcement activities until the funds are spent.

How can I access this?



You can request an interpreter during CAC field inspections or investigative interviews, when you call the CAC office (1-877-378-5463), or if you visit the CAC office in person.

You can also ask CAC staff for the translation of inspection reports, emails, flyers, or notices related to the pesticide use enforcement program.

Which languages are available?



There are over 100 languages available, including: Cantonese, Hindi, Hmong, K'iche', Korean, Mandarin, Mixtec (Alto/Bajo), Punjabi, Spanish, Tagalog, Triqui, and Zapotec.
