GENERAL POWERS FAC §11456	Outlines general powers of the Department of Pesticide Regulation (DPR) in areas of regulation adoption, inspection authority, licensing, and intergovernmental personnel agreements. The Director of DPR is an executive officer appointed by the Governor and has "head of department" powers (Government Code §11150, et seq.). Joint authority for pesticide use enforcement activities is performed by the County Agricultural Commissioner (CAC) under DPR's direction and supervision.

## **Pesticide Use Inspection Authorities**

The Director or CAC may, during business hours or at any other reasonable time, enter and inspect, and/or sample any of the following or related items to determine compliance

Inspect 3 CCR §6140	<ul> <li>with Division 6 and Division 7 of the FAC:</li> <li>Fields, areas, structures, and greenhouses where pesticides are handled/stored/applied;</li> <li>Growing crops/harvested commodities;</li> <li>Equipment used to store/transport/handle pesticides;</li> <li>Protective clothing and equipment;</li> <li>Change areas/other facilities used by employees; and</li> <li>Pesticides and tank mixtures.</li> <li>The person responsible for preparing/maintaining records shall make the records available during business hours, upon demand.
