SUBJECT: WEBINARS ON PROPOSED POLLINATOR PROTECTION MITIGATION

MEASURES FOR USE OF NITROGUANIDINE-SUBSTITUTED

NEONICOTINOIDS IN AGRICULTURAL CROPS

The Department of Pesticide Regulation (DPR) is holding webinars to share information and gather feedback from the public on proposed pollinator protection mitigation measures for the use of nitroguanidine-substituted neonicotinoids in agricultural crops.

BACKGROUND

In July 2018, DPR issued a pollinator risk determination for neonicotinoids. DPR concluded that additional mitigation measures were needed to protect pollinators from the use of the nitroguanidine-substituted neonicotinoids imidacloprid, thiamethoxam, clothianidin, and dinotefuran in agricultural crops. DPR intends to implement mitigation measures through regulations. DPR's regulation proposal will be presented at two webinars. DPR encourages interested parties to attend and provide feedback as to the clarity and workability of the proposal.
