BACKGROUND

As previously noted in California Notice 2020-05, the Department of Pesticide Regulation (DPR) is holding webinars to gather feedback from the public and other stakeholders on proposed pollinator protection mitigation measures for uses of the nitroguanidine-substituted neonicotinoids imidacloprid, thiamethoxam, clothianidin, and dinotefuran in agricultural crops. DPR intends to implement mitigation measures through regulations and will be presenting the mitigation proposal at two webinars.
