Dealer Requirements

- A. Understand the requirements for dealer records of purchases, sales, and distribution (3 CCR Sections 6562, 6572), including requirements for: quarterly reports (3 CCR Section 6568) and supplemental labeling (3 CCR Section 6566)
- B. Understand Pest Control Dealer License responsibilities, including pesticide storage, supervising operations (3 CCR Section 6560 and FAC Section 12258), record keeping, and violations (FAC Sections 12110, 12257)
- C. Identify which pesticides trigger additional dealer responsibilities when sold and what those requirements are, including antifouling paints (3 CCR Sections 6574, 6488), non-fumigants (3 CCR Section 6577), and pesticides containing clopyralid (3 CCR Section 6576)
- D. Know the requirements for the sale and delivery of a pesticide and the circumstances under which the sale and delivery of a pesticide is illegal (3 CCR Sections 6564 and FAC Section 12258)
